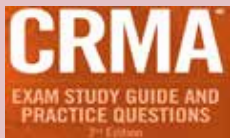

What is the CRMA



For Internal Auditors, and not only, CRMA is the perfect top up qualification for the CIA. While the CIA is a top qualification the unrivalled global Internal Audit credential recognized the world over, and while it reflects Internal Auditing's strong focus on Risk, (as the proxy of Value, Risk Reduction being the main and normal way to fulfil the profession's definition of Adding Value by improving the prospects of achieving the organization's objectives), the CIA is not a certification specialized in Risk Management; but rather, (beside obviously being an Internal Auditing exam), a general Governance qualification. Internal Audit audits Management, supplying Assurance, to Management and Board. And aids Management, by advising it, as a Consultant. As such, it works with Management. There is little to Management, than Risk Management (RM). Thus, the I/Auditor works with RM. He audits RM. And he consults Management on RM. Adding value, improving RM, both indirectly with Assurance from assessing it and directly with Consulting by advising on it. Clearly the extent of value added, of improvement in RM enabled, both through Assurance and consulting services, depends on the extent of the Auditor's expertise in RM. A more RM-knowledgeable auditor is a correspondingly better auditor of, and advisor on RM. Enter the CRMA: makes for a much more RM-knowledgeable auditor. An RM specialist. Empowering the Auditor as an RM improver by making a true specialist, an RM specialist of him. A specialist ESPECIALLY able to make the difference. As simple as that. Auditing is there to add value by helping improve the Risk Management system. CIAs are already provenly – at least to the extent that certifications constitute 'proof' – competent in effecting that. But much more specialized CIAs, both attaining and demonstrating that specialization by acquiring and holding the CRMA, are competent to do it to a substantially higher extent. True SPECIALISTS whose expertise gives them a SPECIAL ability to fulfil their critical RM role, as RM improvers.
