

# Quality Assurance and Improvement Programmes (QAIPs) and Getting the most from an external quality assessment (EQA)

## Course Objectives

Every internal auditor, audit manager and head of internal audit has a part to play in their team's quality assurance and improvement programme (QAIP). Attribute Standard 1300 tells us that, "The chief audit executive must develop and maintain a quality assurance and improvement programme that covers all aspects of the internal audit activity".

To ensure your internal audit function conforms to the IIA's International Standards, regular internal quality assurance activity is required, as well as an independent external quality assessment (EQA) - at least once every five years. However, many internal audit teams have not undertaken such an exercise and many team members do not fully appreciate what is needed to achieve a successful result in an EQA.

This course will help you improve your QAIP, reduce significant findings from an EQA, as well as help you turn this important process into a positive experience that can enhance the internal audit team's added value, efficiency and effectiveness.

#### Who should attend?

Chief audit executives, internal audit managers, senior internal auditors and internal auditors involved in quality assurance and improvement activity in their teams. It is particularly relevant for those considering how to improve their QAIP or who are preparing for an EQA.
