About This Instructor-Led Certificate Program

As an organization grows and its internal processes change and evolve, its quality monitoring process must keep pace. To ensure consistent quality in this dynamic environment, an ongoing commitment to growth and improvement is essential.

The required elements of a Quality Assurance and Improvement Program (QAIP) include periodic internal assessments and external assessments to demonstrate conformance with The IIA's International Standards for the Professional Practice of Internal Auditing. In addition, the QAIP can provide evidence to the audit committee and management that the internal audit activity is efficient, effective, and adding value. It can also build stakeholder confidence and document a commitment to quality, leading practices, and the internal auditors' mindset for professionalism.

This Quality Assessor Certificate Program, based on the curriculum in the instructor-led course «Performing an Effective Quality Assessment» will prepare quality assessor candidates for the certificate exam. A passing score on the exam rewards candidates with a five-year certificate* stating the candidate has successfully completed IIA recognized external quality assessment training and assessment for conducting quality assessments. Those earning the Quality Assessor Certificate will be added to a database on the IIA website - which will increase their visibility as a qualified, external quality assessor - and will receive a digital badge to add to their LinkedIn profile and resume.

**Significant changes to the QAIP requirements and/or methodology associated with performing an effective quality assessment may offer opportunities to take additional courseware with associated examination to maintain certificate status.*

Course Objectives

1. Examine the process flow and tools in the QA Manual.
2. Explore how the process flow and tools in the QA Manual can be used to evaluate conformance with the Standards.
3. Investigate how the process flow and tools in the QA Manual can be used to identify opportunities for continuous improvement.
4. Practice using the QA Manual tools to plan, perform, and evaluate the results of an external quality assessment case study.
5. Discuss how to evaluate the organization's periodic self-assessment as described in the QA Manual tools.
6. Evaluate the external quality assessment options and determine which option will work best for your internal audit activity.
7. Participants who complete the course are eligible to sit for the certificate exam which is administered on The IIA's LMS platform

Who should attend?

This course will provide participants interested in becoming external quality assessors with the appropriate knowledge and skills to plan, perform, and evaluate the results of an external quality assessment. Participants will also learn about the processes and tools in the IIA Quality Assessment Manual (QA Manual) that can help identify opportunities to improve internal audit quality activities. This course will specifically benefit external quality assessors enhancing their skillset to perform IIA Standards based quality assessments.
