Overview

Culture is now explicitly within internal audit's remit. For Chief Audit Executives, the challenge is no longer whether culture should be addressed, but how to do so credibly, proportionately, and without drifting into subjectivity.

This workshop reframes culture as behavioural risk and shows how internal audit can surface meaningful insight into how organisations actually operate. Anchored in the Topical Requirement on Organisational Behaviour, the workshop positions culture not as a standalone compliance exercise, but as a practical audit lens applied across governance, risk management, and controls.
